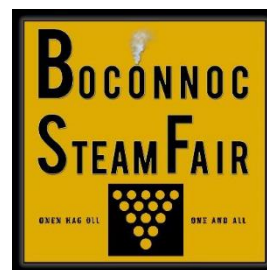

5. The **MAXIMUM** speed of **5MPH** shall apply to all moving vehicles on the site or any part of the Boconnoc Estate. Any exhibitor found to be exceeding the speed limit will be asked to leave forthwith.
